MINUTE OF CHURCHMAN J

- [1] By memorandum dated 7 February 2023, counsel for the majority of the applicant parties have sought:
 - (a) a change in the name that the proposed hearing is referred to from East Coast Wairarapa Group M Stage 1(b) to "East Coast Tāmaki-nui-a-Rua Group M"; and
 - (b) a name change for the 1(a) hearing.
- [2] The memorandum also proposes a timetable order.

Name

- [3] Name allocated to the hearing is for Court administrative purposes only and is not intended to define the precise area that is the subject matter of the hearing.
- [4] When the decision was made to divide the Group M applications into two hearings, it was necessary to distinguish the first hearing (Stage 1(a)) from the second proposed hearing (Stage 1(b)).
- [5] There is potential for confusion if the descriptions Stage 1(a) and Stage 1(b) are altered. I therefore propose leaving the Stage 1(a) as being described as "East Coast Wairarapa Group M Stage 1(a)". I propose amending the second hearing so that it reads "East Coast Group M Stage 1(b).
