MINUTE OF GWYN J (Timetable for filing of evidence)

- [1] On 3 May 2023 I granted leave for Te Tika o Pāpāuma to participate in the Stage 1(a) hearing in respect of the Whareama river mouth.¹ At that stage, Te Hika o Pāpāuma had indicated it was able to comply with existing timetable directions, including to file any evidence in relation to its interests in the Whareama river mouth by 28 April 2023. The grant of leave was predicated on it doing so.²
- [2] Most recently, on 15 May 2023, counsel for Te Hika o Pāpāuma proposed to file the balance of its evidence for participation Stage 1(a) on or before 30 June 2023.
- [3] I have now received a memorandum from counsel for the Attorney-General. Counsel note that on the current timetable the evidence of interested parties is due by 19 May 2023 and the Attorney-General by 16 June 2023. If Te Hika o Pāpāuma does not file its evidence until 30 June 2023 the Attorney-General will not have an opportunity to review and consider all applicant groups' evidence prior to filing his evidence, as allowed for in the current timetable.
- [4] I accept that the Attorney-General, and likely also the parties, would be prejudiced by Te Hika o Pāpāuma's proposed late filing.
- [5] Accordingly, I direct that the balance Te Hika o Pāpāuma's evidence relating to its participation in Stage 1(a) must be filed and served by **5.00 pm 9 June 2023**.
- [6] I signal now that if Te Hika o Pāpāuma is not able to meet that deadline it will be necessary to review the decision to grant leave to Te Hika o Pāpāuma to participate in the stage 1(a) hearing.
