Case Summary	Criminal Appeal – Criminal Procedure Act 2011, s 232(2)(b) – Judge-alone trial – Whether the High Court Judge applied the right standard of review to the applicant's appeal against conviction.
Grounds on which leave was granted	The approved ground of appeal is whether the High Court was correct to dismiss Mr Sena's appeal against conviction brought under s 232(2)(b) of the Criminal Procedure Act 2011.
