

Updating daily recovery rates for costs

- 1. The Rules Committee | te Komiti mō ngā Tikanga Kooti has agreed in principle to increase daily recovery rates for costs of represented parties in the High Court and District Court Rules.
- 2. The Committee proposes to increase daily recovery rates by around 37.8%, in line with the increase in the Producer Price Index¹ (PPI) for legal services since the last time the Committee updated rates in 2018. That is the method by which increases have previously been determined, including in the most recent update in 2018.
- 3. **Attached** as an appendix to this memorandum is an updated table that records the increasing PPI for legal services per quarter up until Q4 2024.² The data in the table reveals an increase of 37.8% in the PPI for legal services from 2017 Q3 (representing the data available to the Committee when it last increased rates in 2018) to 2024 Q4.

The Producer Price Index (PPI) is a metric created by Stats NZ. The PPI reflects average change in selling prices received by domestic producers for their goods and services. It reflects the price changes from the perspective of the producer, not the consumer.

- 4. Increasing daily recovery rates by approximately 37.8% rounded to close whole numbers would result in the following changes in the High Court:
 - a. The rate for Category 1 proceedings would increase from \$1,590 to \$2,200.
 - b. The rate for Category 2 proceedings would increase from \$2,390 to \$3,300.
 - c. The rate for Category 3 proceedings would increase from \$3,530 to \$4,850.
- 5. Increasing daily recovery rates by approximately 37.8% rounded to close whole numbers would result in the following changes in the District Court:
 - a. The rate for Category 1 proceedings would increase from \$1,270 to \$1,750.
 - b. The rate for Category 2 proceedings would increase from \$1,910 to \$2,650.
 - c. The rate for Category 3 proceedings would increase from \$2,820 to \$3,900.
- 6. The Committee is not proposing to increase costs for self-represented litigants.
- 7. The Committee invites submissions from the profession on the proposed increases. To be considered, submissions must be sent to the clerk to the Rules Committee by 5.00pm Friday 5 September 2025.
