MINUTE (NO. 15) OF CHURCHMAN J

[1] On 7 May 2021, counsel for the Attorney-General filed a memorandum in this matter. The memorandum indicated that, as a result of developments in the recently heard Ngā Pōtiki proceedings (CIV-2011-485-793), the Attorney-General now considers that it is possible that s 5 of the Foreshore and Seabed Endowment Revesting Act 1991 may have altered the common

law position and achieved a statutory revival of customary interests in some parts of the coastal marine area within Te Whanganui ā Ōrotu and the Napier Port and Harbour areas.

- [2] This development represents a change of position in relation to the submissions made by the Attorney-General at the hearing of this matter. In particular, it is relevant to the application of Ngāti Pārau.
- [3] In these circumstances, it is appropriate that the Attorney-General file further submissions on this point and that Ngāti Pārau (being the only applicant potentially affected by this issue) be given a right of reply.

Result

- [4] The Attorney-General is directed to file and serve by **5pm Friday**, **21 May 2021** further submissions on the implications of s 5 of the Foreshore and Seabed Endowment Revesting Act 1991 in relation to the claim in these proceedings by Ngāti Pārau.
- [5] Ngāti Pārau are to file and serve by **5pm Friday**, **28 May 2021** any submissions in reply.
