# MINUTE (NO. 6) OF CHURCHMAN J [Case Management Conferences 2022 – Hamilton]

CIV-2017-419-81

[1] Counsel's application for leave to attend the 15 June 2022 CMC by AVL is granted.

CIV-2017-485-207

[2] Preliminary engagement with some overlapping applicant groups has been undertaken. Historical research is likely to be finalised by the end of 2022 and traditional evidence gathering has commenced.

[3] The applicant seeks the adjournment of its application to the 2023 Hamilton CMC and for counsel's attendance on 14 June 2022 to be excused.

[4] Those applications are granted and the matter will be called again on Tuesday 20 June 2023 at 10am.

[5] Historical research is well underway with a final report likely to be available this year. Tangata whenua research is underway. There are ongoing discussions with overlapping claimants. This applicant asks for the claim to be adjourned for six months with a further reporting date set for early December 2022, and also request that counsel's attendance at the CMC on 14 June 2022 be excused.

[6] The application is adjourned to a further CMC which will be scheduled in December, possibly on 12 December 2022, but the Registrar will confirm the date and time. Counsel's attendance on 14 June 2022 is excused.
