MINUTE OF GWYN J (Te Hika o Pāpūma)

[1] This minute addresses some matters that have arisen in relation to Te Hika o Pāpāuma's participation in the Stage 1(a) hearing and the PCR orders sought in its further amended application.

Timetable for Te Hika o Pāpāuma participation in the Stage 1(a) hearing in relation to the Whareama River mouth

- [2] On 3 May 2023 I issued a minute in relation to the Northern Boundary for the Stage 1(a) hearing in which I granted leave to Te Hika o Pāpāuma Mandated Iwi Authority to participate in the Stage 1(a) hearing in respect of the Whareama River mouth.1
- [3] The grant of leave was predicated on Te Hika o Pāpāuma filing all evidence required in relation to the Whareama River mouth in accordance with the existing Stage 1(a) timetable.
- [4] Mr Hirschfeld, counsel for Te Hika o Pāpāuma, has since clarified his memorandum of 27 April 2023 and advises that the evidence in relation to the river mouth is not complete. Te Hika o Pāpāuma would be able to have the remaining evidence for Stage 1(a) filed by 30 June 2023 (I note the due date for interested party evidence is 19 May 2023 and for the Attorney-General's evidence it is 16 June 2023).

[5] Mr Hirschfeld has advised other parties of that proposed date. The Registrar is consulting with hearing participants to ascertain if there is any opposition to Te Hika o Pāpūma filing by that date.

Te Hika o Pāpāuma's role in the Stage 1(a) hearing

[6] In the meantime, for the avoidance of doubt, if Te Hika o Pāpāuma is to participate in Stage 1(a) of the Group M hearing, it will be as an applicant and not as an "interested party" as stated in counsel's memorandum dated 27 April 2023.

Confirmation of PCR orders sought in further amended application

- [7] On 10 May 2023 I issued a judgment in relation to Te Hika o Pāpāuma's further amended application.² I sought clarification from counsel whether it was the intention of the further amended application that "recreational use" and "resource extraction" for fossils are no longer being sought as PCRs.³
- [8] Counsel has confirmed that PCRs are sought in relation to these two categories.
