MINUTE OF GWYN J (Third amended application re Whareama River mouth)

[1] In my minute of 3 May 2023,¹ I directed Ngāi Tūmapūhia to clarify their position regarding the application area as it relates to the Whareama river mouth and in particular whether it seeks to amend its application area.

[2] Counsel have now filed a memorandum dated 19 May 2023, together with a third amended originating application for recognition orders (third amended application).

[3] The third amended application seeks leave to amend the northern boundary description in the following manner:

Amend from	То
"starting at the Whareama River	"starting at the northern bank of the
(41°01.00'S 176°06.50'E) in the North"	Whareama River in the North" ²

[4] In addition, counsel say for the sake of consistency and in the interests of specificity, leave is also sought to amend the southern boundary description in the following manner:

Amend from	То
"down to the mouth the Pahoao (sic)	"south to the southern bank of the
River in the South (41°23.10'S	Pāhaoa River ³
175°45.20'E)"6	

[5] Counsel submit that the proposed amendments are refinements of Ngāi Tūmapūhia's application area; the amendments sought merely specify where Ngāi Tūmapūhia's northern and southern boundaries are in relation to the Whareama and Pāhaoa river respectively. Counsel note that the evidence in support of the application remains relevant and, in their submission, this confirms that the essence of the application has not changed. Counsel also note that the proposed boundary

amendments do not have the effect of drawing in any new overlapping applications, nor cause prejudice to any parties.

[6] I accept that the proposed amendments to the northern boundary description and the southern boundary description can appropriately be characterised as "refinements" of the existing application.

[7] Accordingly, leave is granted to amend the descriptions in the manner sought in the third amended application.
