- [1] At the conclusion of the wāhi tapu evidence last week counsel indicated that they wished to file a joint memorandum addressing finalisation of the questions to be addressed by Dr Joseph in his Pūkenga Report, and timetabling matters.
- [2] Counsel for the applicants and the Attorney-General have filed a joint memorandum dated 28 July 2025 addressing those issues. The memorandum advises that counsel for the Greater Wellington Regional Council, Horizons Regional Council and Central Hawke's Bay District Council have confirmed they do not oppose the contents of the joint memorandum. The memorandum advises that counsel for the Trustees of Pāpāuma Marae, Ngāti Kere, Ngāti Kahungunu and the Seafood Industry Representatives were part of finalising the joint memorandum but their acceptance of the finalised wording has not been confirmed.

Questions to be addressed in the Pükenga Report

- [3] Counsel propose some amendments to the questions addressed by Dr Joseph in his Pūkenga Report prepared in the Group M Wairarapa Part 1(a) wāhi tapu proceedings.
- [4] I am grateful to counsel for their memorandum. I agree that the questions as amended are those that Dr Joseph should address in his Pūkenga Report. Subject to any further comments from those parties who have not had an opportunity to confirm their final acceptance of the proposed wording, I ask counsel to file an unannotated version of the questions to be addressed by the Pūkenga.

Timetable

[5] The parties have proposed a timetable leading up to and including the week of 11 August 2025 which the court has set aside to conclude the wāhi tapu hearing. The proposed timetable recognises the need for some further applicant evidence to be filed and tested (as I indicated at last week's hearing), as well as the filing and presentation of closing submissions.
