
MACA Central Bay of Plenty Hearing Overview

1. Hearing Area

This hearing was allocated by Churchman J in December 2022¹ to deal with MACA applications in "the area between the eastern boundary of the Re Reeder priority proceedings and the western boundary of the Re Edwards priority proceedings".

In the map below², hearing area is the central orange section. Re Reeder (Ngā Pōtiki) is the green section on the left and Re Edwards (Whakatōhea) is the green section on the right.



2. Dates and venue

On 19 December 2024, following a request from applicants, Powell J adjourned the hearing without date.³ A case management conference will be convened in November 2025 to confirm next steps. In the interim, an 8-week hearing on 4 October 2027 has been reserved.
