MACA Group M Hearing Overview


1. Hearing Area

The Attorney-General proposed a set of map groupings for MACA applications in 2017¹ that were formally adopted in 2018². Group M included the coastline from <u>Arataura</u> in the north to <u>Turakirae Head</u> in the south.

The Group M hearing was allocated by Churchman J in July 2022³. In November 2022 the hearing boundary was extended northward to include the coast up to <u>Ouepoto Stream</u>.⁴

The hearing area is divided into:

- Stage 1B The northern portion from <u>Ouepoto Stream</u> in the north to <u>Whareama River</u> in the south.
- Stage 1A The southern portion from Whareama River in the north to Turakirae Head in the south.



2. Dates and venue

Stage 1A will be heard over 8 weeks starting 4 September 2023. For the first four weeks, the Court will sit at the Solway Centre in Masterton. The last four weeks will be heard at Wellington High Court.

Stage 1B will be heard over 8 weeks starting 12 February 2024 at the Wellington High Court.
