
MACA Ngā Pōtiki Hearing Overview

1. Hearing Area

Ngā Pōtiki a Tamapahore Trust are a priority applicant under <u>section 125</u> of the MACA Act. In 2019 they proposed that their application be determined in two separate hearings:

Stage 1: Rangataua Inner Harbour

Stage 2: The Seaward balance of their application area including Motiti Island



This hearing scheme was approved by Churchman J¹ and hearing time was allocated.

2. Dates and venue

Rangataua CMT Hearing

The Stage 1 Rangataua Inner Harbour hearing was heard by Powell J at Papamoa over 3 weeks starting on 19 April 2021. A CMT decisions was issued on 12 October 2021².

Rangataua CMT Hearing

There was a second hearing on 3 December 2022 to consider wahi tapu status and restrictions. The wahi tapu decision is currently reserved.

Ngā Pōtiki Stage 2 (Seaward) CMT Hearing

The Court sat for four weeks from 28 September 2021 to hear applications included in the seaward portion of the Ngā Pōtiki application area. Powell J's CMT decision is still pending. These proceedings are affected by the passing of the CMT Amendment Act on October 24 2025³. Schedule 1AA clause 3⁴ of the amended MACA Act requires that the Ngā Pōtiki Stage 2 CMT decision be considered under the new CMT test.

This further consideration may require further hearing time.
