Chief Justice's Annual Report released today

Chief Justice Helen Winkelmann has today released her 2024 Annual Report. The report provides information about judges, about the role and responsibilities of the judicial branch of government, and about the work of the courts in 2024.

The *Chief Justice's Annual Report 2024* also describes the priorities of judicial leadership for the year. These include initiatives to improve access to justice, to address court delays, and to respond to the recommendations for the judiciary in the final report of the Royal Commission of Inquiry into Abuse in State and Faith-based Care. A key focus for the judiciary continues to be modernising the courts' systems and processes, and ensuring that any courtroom technology assists rather than hampers access to justice.

The report is intended to support public understanding of the courts, and to enable public scrutiny of how they are administered, the Chief Justice said today.

"Judges usually speak only through their judgments. This report provides the opportunity for the judiciary to speak publicly about the functioning of the courts, and in particular the challenges and opportunities for access to justice and the operation of the courts."

"The judiciary has a unique perspective on these topics, formed through the daily work of administering justice through the courts, and it is essential that this perspective is heard."
